1 Briefly describe the organization's mission: When people face homelessness, Old Pueblo Community Services offers housing, counseling and support services to help them transform their lives.

4a (Code:) (Expenses \$ 417,515. including grants of \$ 152.) (Revenue \$ 410,039.) Housing Development - Our Housing Development Department is almost complete as of 12/31/16. OPCS provided reverse mortgage counseling and down payment assistance to 393 clients. The final three homes will be completed and sold in 2017. At this time OPCS has deemed rehabilitation and construction outside of our mission. We will continue to help those in need of financial education, budgeting and life skills through this department.

4b (Code:) (Expenses \$ 3,163,353. including grants of \$ 1,800.) (Revenue \$ 147,949.) Reentry Communities - Transitional Housing and/or Counseling and Case Management for both veteran and non-veteran clients. In 2016, we served 1091 clients. 853 clients were male and 253 clients were female and 3 clients were transgender. We provided housing, case management, recovery support services and/or counseling. Of these clients, 933 (85%) had some type of disability and 143 of them were considered chronically homeless. We also served 38 households with children in our permanent supportive housing families program.

We continue to serve reentry clients as they are released from both jail and prison to engage in our intensive outpatient therapy after release. This program is a 60-90 day program post release, including

We have received numerous contracts to help clients enter permanent supportive housing. We have contracts for over 152 permanent supportive housing contracts. These are funded through various agencies at the city, state and federal level. The evidence has shown that when a homeless person gets a permanent place to live, their lives become much more manageable.
