Housing Development/Home Ownership - The department assisted 155 families/individuals with homebuyer education, down payment assistance, & HUD certified housing counseling. Our staff counseled 202 families/individuals facing foreclosure, & 169 homeowners interested in reverse mortgages. W assisted 2 first-time home buyers in buying a new home at Sunnyside Pointe and CNEW. In addition, we renovated 20 owner-occupied homes.

4b (Code:) (Expenses \$ 3,068,394. including grants of \$ 764.) (Revenue \$ 442,560.) Recovery Communities - Transitional Housing and/or Counseling for both veteran and non-veteran clients. In 2014 we served 516 males, 174 females and 2 crossgender clients with housing, case management, recovery support services and/or counseling. Of these clients, 237 of them were diagnosed as chronically mentally ill. We also served 52 households with children in our scattered site lease programs. Our outpatient programs served 414 clients.

We began the next Inside Out Recovery Program in the fall of 2014 and are targeting clients from the jails to provide intensive outpatient therapy after release. The One Step at a Time grant also started this fall and its clients come from our Arizona prisons. This is also

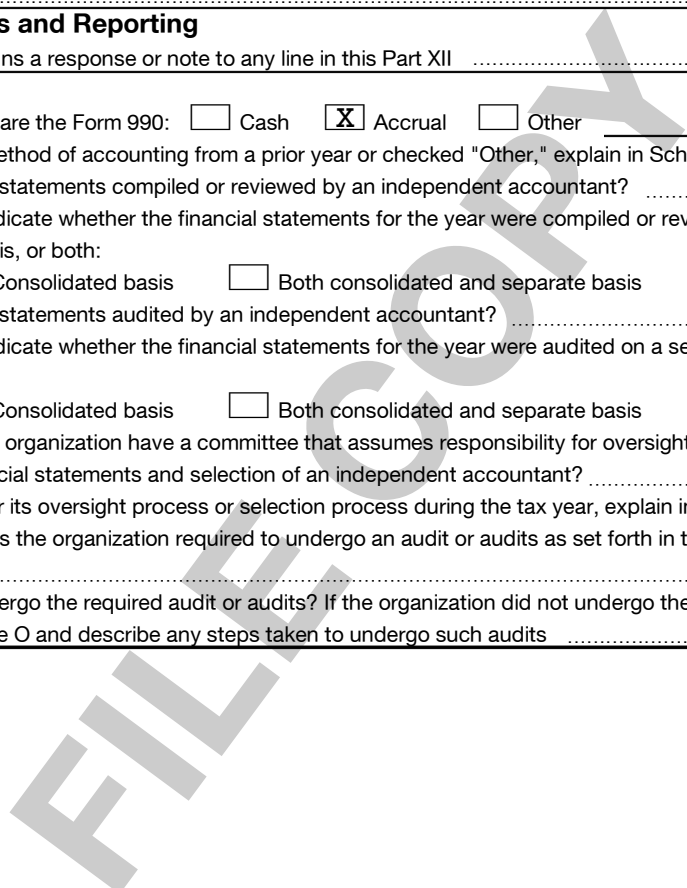

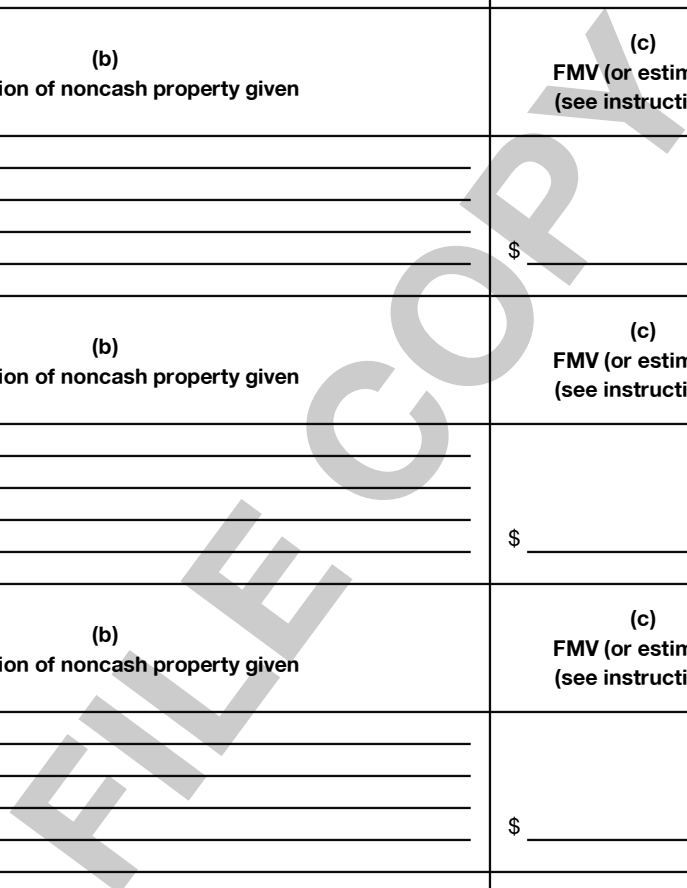
