## **Duties and Responsibilities:**

- Deliver peer recovery support services under the direction of the Clinical Manager and Reentry Program Manager.
- 2. Utilize experiential knowledge through supportive story telling.
- 3. Facilitate life skills peer groups that address substance use, health and wellness, prevention, criminal thinking, nutrition/meal preparation, housing stability, vocational needs, and activities of daily living.
- 4. Coordinate and provide transportation for outings and support group meetings as needed.
- 5. Implement elements of Client Recovery Plans as assigned.
- 6. Maintains client records and information, documenting services provided within the CT1 electronic health record in a confidential manner and in compliance with HUD and HIPAA standards.
- 7. Administer and document client UAs.
- 8. Attend all mandatory trainings and maintain required certifications.
- 9. Attend and participate in daily staffing.
- 10. Other duties as assigned.

#### **Qualifications:**

Minimum of six weeks of behavioral health work experience and a preference of one year experience. (Experience may be gained after employment though six weeks of continuous onsite direction from a behavioral health professional, technician, or a paraprofessional who has a minimum of six months behavioral health work experience.) Credentialed as a PRSS by completing training through PSETP and passing the competency exam. Certification may be obtained within 6 months of hire. Minimum High School Diploma or GED. Preferred graduate from Recovery Support Institute. Have knowledge of and ability to utilize Evidence Based behavioral health interventions for persons in recovery from substance abuse and/or substance dependence. Ability to learn and use evidenced based practices such as Motivational Interviewing, Familiarity with Housing First, Harm Reduction, and Trauma Informed principles. Possess and maintain a valid CPR/First Aid Certification. Must have a valid Arizona Driver's License and qualify to be added to auto insurance. Also, must have proof of insurance and reliable transportation. Able to work flexible schedule, including evenings and weekends. English usage, spelling, grammar, and punctuation. Strong communication skills, both written and verbal. Abide by laws and rules regarding delivery of outpatient services for person identified with substance use and/or mental health issues. Ability to appropriately respond to a situation in which a client may be a danger to self or danger to others, behaves in an aggressive manner, or may be experiencing a crisis situation, or a medical emergency.
